

Date	Doors (% Leaks)	Lids (% Leaks)	Off-takes (% Leaks)
2015 Thresholds (July 2 start)	54%	2%	NA
2016 Thresholds	32%	2%	NA
2017-2019 Thresholds	10%	2%	5%
2020 - 2023 Thresholds	5%	1%	4%
January – March 2023 Range (Average)	0 – 4.28% (1.24%)	0 – 0.53% (0.07%)	0 – 2.60% (0.41%)
